Petitioner Father Jean-Pierre Gillain and Respondent Mother Zoe McLellan are the parents of minor child Sebastian, born October 16, 2012. The April 14, 2016, judgment in this case granted the parties joint legal and joint physical custody of Sebastian. Following a hearing in 2018, the court modified the parenting schedule, but both parties continued to have joint legal and physical custody. See May 29, 2018, Minute Order and July 26, 2018, Order After Hearing. In conjunction with Respondent Mother's July 9, 2019, domestic violence restraining order (DVRO) application, Respondent Mother was granted temporary sole legal custody and physical custody of Sebastian with no visitation to Petitioner Father. Respondent Mother was also ordered not to remove the child from California without a court order.

1 Respondent Mother moved with the minor child Sebastian to Louisiana without court approval in  
2 violation of Family Code section 3063 and the terms of the July 9, 2019, temporary restraining order.

3 On July 7, 2020, the court ordered Respondent Mother to have Sebastian physically present in court for  
4 a hearing on July 17, 2020. On July 17, 2020, Respondent Mother failed to appear or produce the child.  
5 The court dissolved the July 9, 2019, temporary restraining order, ordered that the parties share joint  
6 legal custody of Sebastian, and ordered Respondent Mother to produce the child's school and medical  
7 records to Petitioner Father. On September 17, 2020, the court set a hearing date of September 29,  
8 2020, for Respondent's July 9, 2019, DVRO request and her February 14, 2019, request for modification  
9 of custody. Respondent Mother was given notice of the hearing.

10 On September 29, 2020, Respondent Mother failed to appear. The court received evidence,  
11 denied Respondent Mother's DVRO application and issued custody orders contained in a September 29,  
12 2020, Minute Order. The court set a continued hearing on the Petitioner's pending request for  
13 modification of custody for November 9, 2020. Respondent Mother was given notice of the hearing.

14 On November 9, 2020, Respondent Mother failed to appear. The court awarded Petitioner  
15 Father sole physical custody of Sebastian with no visitation to Respondent Mother. The court further  
16 ordered that Petitioner Father would have sole legal custody effective upon Sebastian's return to  
17 Petitioner Father's physical custody. See November 9, 2020, Minute Order and December 8, 2020,  
18 Order After Hearing.

19 **IT IS NOW FURTHER ORDERED** that pursuant to Family Code sections 3130 through  
20 3134.5, the District Attorney of Los Angeles County is authorized and directed to conduct an  
21 investigation and to take all actions necessary to locate Respondent Mother and Sebastian and to procure  
22 compliance with the custody order in the above entitled matter by taking the following action upon  
23 locating Sebastian: **Take temporary custody of the child, Sebastian, and turn him over to the**  
24 **Petitioner Father, Jean-Pierre Guy Gillain. Serve a copy of this order on Respondent Mother Zoe**  
25 **McLellan.**

26 Respondent Mother Zoe McLellan is ordered to appear in person at the next hearing date on  
27 April 26, 2021, at 8:30am in Department 65 of the Stanley Mosk Courthouse, 111 North Hill Street, Los


1 Angeles, California. If Petitioner Father does not have physical custody of Sebastian, Respondent  
2 Mother must bring Sebastian to court for the hearing. Petitioner Father is also ordered to be present.  
3 Respondent Mother may serve and file a responsive declaration no later than April 13, 2021. Violation  
4 of this order may subject a party to sanctions of up to \$1,500 under Code of Civil Procedure section  
5 177.5.

6 The court has made a finding that the minor child Sebastian was born in the United States and  
7 has resided in the State of California, County of Los Angeles. This court has jurisdiction of this matter  
8 under the Uniform Child Custody Jurisdiction and Enforcement Act.

9 District Attorney investigators may contact this court ex parte and without notice to the parties to  
10 obtain further orders required by any jurisdiction in which the child is found to effectuate the order.  
11 District Attorney investigators may contact the court ex parte concerning any fact the investigator  
12 believes would be material to the welfare or safety of the child as related to enforcement of this order.
