Woman in apt. #4 saw and advised a young man fitting Matt Nolan's description, trying to climb the fence to my the back of my apartment and noted that he had loitering of some time. It was that time that I was again advise to not be alone, buy and carry pepper spray and obtain a restraining order. My apt. manager informed me that all the residence of my security apartment building had

be advised of the situation and flyers had been sent out to each person with Matt's description. It is very important to note that I live in a security building. Also know that the entire property is fenced and access to the rear of the building is not easy. But once someone is over or through the fence access to my bedroom window is easily accessible because live on the ground floor.

- He entered my apartment with his keys. Opened my mail (phone bill) and teased me down in Oregon.
- decided to move Feb 1, 1997. Stayed in hotel until there was out of town working on tv show. Received numerous phone calls at all hours of the night and day from Matt Nolan. I did not tell him I had the job, where I was <sup>in San Diego</sup>. He must have gotten into my apt and listened to my messages. I blocked my hotel phone after talking him not to call me.
- numerous letters, long letters.
- numerous phone calls.
- numerous faxes to my home fax.
- He has been around my apartment on numerous occasions.
- I have blocked his work + home # from my phone.
- My friends <sup>and</sup> my manager have pleaded with him to leave me alone. He promised each of them that he would.
